

## **Performance Agreement**

This Agreement is made on October 30, 2025 between Downtown Austin Alliance (“Presenter”) and Amber Williams, professionally known as “Amber Blue” (“Performer”) for a live children’s music performance as part of the Holiday Sing-Along and Stroll (“Event”).

### **1. Event Details**

Date: December 6, 2025

Location: Congress Avenue

Performance Time: 5:00 PM – 5:50 PM

Load-In / Soundcheck: TBD

### **2. Performance**

Performer will provide a live children’s music show suitable for family audiences, approximately 45-50 minutes, featuring singing, acoustic guitar and ukulele performance, dance track music, and interactive participation. Performer will take part in the scheduled sound check, ensure they are prepared to perform at least 30 minutes before showtime, and remove personal gear and props promptly after performance.

### **3. Guest Performer**

Performer may bring one guest performer or assistant to accompany the show for the purpose of providing supporting vocals, demonstrating dance movements, and assisting with audience participation or prop distribution. Presenter will be notified in advance of the guest’s name and role. The guest will adhere to the same professional conduct standards as Performer.

### **4. Compensation**

Performance Fee: \$300

Payment will be made by direct deposit within 7 days of performance. A completed W-9 will be provided by Performer if required.

### **5. Cancellation**

If Presenter cancels Event less than 7 days before the scheduled performance (for reasons other than weather or force majeure), Performer shall receive 50% of the agreed fee.

If Event is canceled due to severe weather or safety concerns, no payment will be due unless otherwise agreed in writing.

If Performer must cancel due to illness or emergency, they will notify Presenter as soon as possible to allow time for adjustments or replacement scheduling.

## 6. Production & Equipment

Presenter agrees to provide sound reinforcement as outlined in the attached Tech Rider, or to notify Performer at least 7 days prior if alternate arrangements are needed.

## 7. Promotion & Photography

Performer grants Presenter permission to use name and likeness as it pertains to Event promotion and post-event content. This permission does not extend to any unrelated advertising, sponsorship, or future events without Performer's written consent.

## 8. Liability

Presenter shall provide a safe performance environment and is responsible for audience and site safety. Performer is not required to carry separate insurance.

## 9. Merchandise

Performer may sell or distribute CDs, merchandise, or related items at the event and will retain 100% of sales proceeds.

## 10. Agreement

Both parties agree to the terms listed above.
